## VPE Virtual Board of Directors Meeting on April 30



# President's Message

Dear Neighbors,

We are committed to keeping you informed about the state of the restrictions in the wider community, Leisure World and VPE. We will continue to put fliers under your door, in the elevators and on the bulletin boards to keep you informed.

It is up to you to keep yourself safe. Staying home and away from others is the best solution, as suggested by all. Since this is your home, it is you who invite friends, family, and support persons into the building at your request. **THIS IS THE MAJOR RISK TO YOU AND YOUR NEIGHBORS.** Please be prudent and make sure that during the visit, they follow the guidelines with masks and distancing.

As president of our Mutual and also Secretary and Treasurer of the Leisure World Board of Directors, I am aware of the financial prognosis of the overall community by reviewing its budget and future obligations. Over the past 50 years our Leisure World community has had the financial resources to provide well-maintained facilities and a safe community in which to live. It is becoming more difficult to have sufficient resources to do so.

Leisure World has attempted to limit the effect of cost increases and revenue decreases while still maintaining the quality of lifestyle expected by owners and residents. The ability to do that without additional financial assistance appears to be coming to an end, likely near the end of 2023. The key reasons for the expected financial constraints include increased labor costs, increased costs to maintain/replace aging facilities and demands for additional amenities.

To prepare for the future, the Leisure World Board has evaluated the estimated financial resources that will be available to fund future overall community needs. Three sources of income are used for the operations of the community. These are Community Facilities Fee (part of your Condo fee), lease income and interest income. These sources of income have limits. In the past, every effort has been made to limit the increase in the Community Facilities Fee you pay as part of your condo fee. In addition, outside sources, such as lease payments from third parties, are limited to prevailing market rates. Similarly, investment account interest income is currently exceptionally low. In sum, because of these constraints, these three income sources

alone will no longer be adequate to fund the future operations and reserve fund needs of the community.

The last source of income, the fee from property transfers (a resale fee into the Resales Improvement Fund), is restricted to only expanding or renovating existing Trust facilities or for the construction of new Trust facilities. Presently, the Trust collects 2% of the selling price paid by the purchaser of every unit. The 2% property transfer rate has been in effect since October 2002. The analysis of the Resales Improvement Fund also shows the significant challenge for continuing to enhance Trust facilities well into the future. During the past four years major improvements have been made to the community and will continue to be made using the funds collected from past property transfers and managed according to the guidelines of the Facilities Enhancement Plan (FEP) approved in 2014.

In the next several months a new request for proposals will be made to the community at large for future facility enhancements to the community. Proposals that are anticipated include upgrades to the auditorium and changes to the outdoor pool area. Additionally, the new strategic plan may suggest additional priorities for facility improvements and modifications for the LW community. It is felt that the current 2% property transfer fee will be inadequate to enhance the facilities in the community.

A proposal that has been made is to move forward with the facility improvement proposals and to fund them via an increase in the property transfer fee to 3% effective in January 2021. An increase by 1% to the property transfer fee starting in 2021 would provide adequate additional funding to maintain and expand our community facilities by being able to fund future FEP projects and augment operational needs like the community facility reserve fund.

Leisure World is preparing a package on the overall financial situation of the community for your information on this subject. Currently, we have no idea of the consequences of the current pandemic and possible increasing pressures on the budget. This may impact sales of units and affect income and operating costs. During this time when we cannot meet in a town hall session and provide you with additional information, I ask your forbearance in waiting to see how the current pandemic will pan out and affect our community financial situation. No action is planned to be taken on the proposed increase in the proper-

- replacement of the defective compressor that services the fire control room on the lobby level of the building for \$1,944.00. Funds to come from the Replacement Reserves Account.
- the Culbertson Company proposal in the amount of \$2,640.00 to remove and replace ballast, concrete pavers and insulation to repair the roof over the living room area of Unit 1001. Funds to come from Replacement Reserves Account.

## Budget & Finance Quarterly Report

The following is the unaudited VPE financial report through the first quarter (1Q20).

YTD Surplus (Deficit)	\$ 5,148	(\$ 19,936)

The overall financial condition of the Association remains sound. The Association has been returning accumulated surplus to unit owners through lower condominium fees. This has resulted in a planned deficit but has not, to date, significantly affected the financial condition of the Association. Through the first quarter, the Association's financial performance was ahead of budget, mainly because of lower utility expenses, but also because of somewhat lower operating expenses.

Additional information may be obtained by attending the monthly Budget & Finance Committee meeting. Also, financial statements are available for examination in the Association Office by appointment with the Property Manager.


## Auto-isolation (*Self- isolation*) Spring In the Parking Lot

As we sit here wondering, “why us?” I realize that that many of us have been lucky to observe the world’s suffering from afar. History tells us these afflictions are not new, but now we can know what causes them. After three plus millennia, the ten plagues inflicted by the Deity on the Pharaoh and his people are recited every Passover. Misuse of power brought the plagues to Egypt. That and other evils were the cause of epidemics and plagues. In more recent history, the Deity was often offended by humanity in the medieval period with its loose morality. A deadly plague was needed to get the medieval world in order.

The Renaissance brought elements of science to bear on dealing with epidemics. Then as now, contagion was more prevalent at the bottom of the economic ladder. If plague spread in a city, those who had the means would flee to the countryside. The rest stayed in the city with the infected rats and fleas and the generally abundant filth in the streets. They breathed the rising noxious vapors. Water supplies were filthy—safer to brew it into beer. Seemingly clean wells and communal pumps cause cholera and typhoid epidemics into this century. Germ theory and study became popular among the 1800s physician/scientists – Lister, Pasteur, Semmelweis—who made great, but simple, contributions to public health. Wash hands in between seeing or touching patients, Semmelweis, 1847. Heat milk before drinking/selling, Pasteur, pasteurizing, 1863. Sterilize surgical instruments before use, scrub hands before surgery – Lister, who adopted Pasteur’s germ theory, 1870s.

I am not sure who discovered that germs/viruses are transmitted by fluent speech or coughs and sneezes. It is hard to remember not to use our hand, but the crook of our arm. One thing we are sure of is that finger lickers don’t remember germ theory as they slurp the residue then break a roll and put half in the basket.

Meanwhile, the rest of us are enjoying our auto-isolation and wonder what we did now to deserve this? Does anyone recall the “Quarantine – SCARLET FEVER” signs attached to front doors when we were kids? I don’t remember what It was, other than it was very serious! I

## Spring Book Choices

### Afghan Family History, Pakistani in Wake of 9/11

VPE Book Club members were disappointed that the March meeting was canceled. Everyone found *The Two-Family House*, by Lynda Cohen Loigman, engaging and was eager to discuss it. An engrossing family saga set in post-war Brooklyn, it was recommended to the group by Sandra Margulies and described in detail in the March View, in case anyone might like to read it.

Although virtual meetings are taking place and I've been fortunate to participate in several, someone needs to set them up and run them. In addition, one member of the Book Club does not have a computer, and another member has one but doesn't use it. Whatever the future holds, I'd like to at least mention the spring book selections in case anyone might be interested in acquiring a hard copy or digital version.

***A Thousand Splendid Suns***, by Khaled Hosseini (*The Kite Runner*). Born a generation apart and with very different ideas about love and family, Mariam and Laila are two women brought jarringly together by war, by loss and by fate. As they endure the ever escalating dangers around them—in their home as well as in the streets of Kabul—they come to form a bond that makes them both sisters and mother-daughter to each other, and that will ultimately alter the course not just of their own lives but of the next generation. With heart-wrenching power and suspense, Hosseini shows how a woman's love for her family can move her to shocking and heroic acts of self-sacrifice, and that in the end it is love, or even the memory of love, that is often the key to survival. (Library description)

***The Reluctant Fundamentalist***, by Hamid Mohsin. Changez is living an immigrant's dream of America. At the top of his class at Princeton, he is snapped up by an elite valuation firm. He thrives on the energy of New York, and his budding romance with elegant, beautiful Erica promises entry into Manhattan society at the same exalted level once occupied by his own family back in Lahore. But in the wake of September 11, Changez finds his position in his adopted city suddenly overturned, and his relationship with Erica shifting. And Changez's own identity is in seismic shift as well, unearthing allegiances more fundamental than money, power, and maybe even love. (Library description) The book was recommended by Suzie Offit.
